



# Cat Adoption Contract

1. I agree to provide proper and sufficient food, water and humane treatment to this cat at all times.
2. I understand that it is my responsibility to evaluate this cat for myself before agreeing to this adoption.
3. I will seek veterinary care if this cat becomes sick or injured and to keep current on vaccinations. \*See Disclaimer
4. I agree to keep this cat safely indoors for an appropriate duration of time, before allowing this cat to venture outside. For the safety and long life of this cat, I will do my best to bring them indoors at night.
5. I agree to minimize and supervise contact between my newly adopted cat and small children and any other pet in my household for 7 to 10 days after adoption.
7. I understand that when I transport this cat that it will be in a crate or cat carrier at all times for its own safety.
8. I will not hold Colville Valley Animal Sanctuary or its representatives responsible for any damage, accident or injury resulting from the placement of this cat in my household.
9. I agree to allow CVAS to contact me by phone, email or in person to insure this cat is properly being cared for and determine that this adoption is successfully meeting the expectations of my family and the Sanctuary.

## **PLEASE INITIAL THE FOLLOWING:**

**10. If for whatever reason the cat does not work out in the home at any time after the adoption, I will contact CVAS immediately and arrange to bring the cat back. I will not attempt to re-home, sell, or abandon the cat for any reason. \_\_\_\_\_**

**11. I understand that if a CVAS representative feels that this cat is in an unsafe or unhealthy environment, the representative has the right and responsibility to**

12. I understand that animal abuse, neglect or abandonment is a class III felony in the state of WA. CVAS supports taking any action necessary to prosecute anyone that is in violation of this law. \_\_\_\_\_
